State Fund for Guaranteeing the Stability of the State Pension System

The resources of the Fund as of **30.06.2019** total to **BGN 3 081,41 million**, of which BGN 3 067,00 million is held in an annual deposit in the Bulgarian National Bank with decision of the Managing board of the Fund.

In accordance with the provisions of paragraph 4 of article 1 and article 11 of the State Fund for Guaranteeing the Stability of the State Pension System Act in relation to paragraph 12 of article 129 of the Social Security Code in June 2019 the amount of **BGN 13,84 million** was transferred to the Fund's account.
