1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue no. 677 of April 30, 2006.
2. The Republic of Bulgaria has received a loan from the International Bank for Reconstruction and Development towards the cost of Second Trade and Transport Facilitation Project and intends to apply part of the proceeds of this loan to payments under the Contract "Supply, Configuration and Licenses for Portable, Mobile and Stationary TETRA Radio Terminals for Border Agencies".
3. The Ministry of Finance through the Project Implementation Team (PIT) is implementing the project and now invites sealed bids from eligible and qualified bidders for supply and installation of the following Goods:

Lot 1: "Supply of Portable, Mobile and Stationary TETRA Radio Terminals for Border Agencies"

- Portable Hand-Held TETRA Radio Terminals – 2,200
- Mobile TETRA Radio Terminals – 340
- Stationary TETRA Radio Terminals – 10

Lot 2: "Supply of Licenses for TETRA Network of Border Agencies"

- Software Licenses – 2,600

Bidders are allowed, at their option, to bid for any or all Lots under this ICB. Each Lot shall be evaluated and contract awarded separately to the Bidder offering the lowest evaluated price for each Lot. Bidders must bid for all the items and in the quantities specified in the List of Goods and Related Services for each Lot, furnished in Section VI, Schedule of Requirements of the Bidding Documents.

4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, May 2004, and is open to all bidders from Eligible Source Countries as defined in the Guidelines.
5. Interested eligible bidders may obtain further information from PIT and inspect the Bidding Documents at the address No.1 given below from 2.00 PM to 4.00 PM Sofia time.
6. Qualifications requirements (financial capacity, experience and technical capacity of the Bidder) for each of the five Lots are specified in Section III, Evaluation and Qualification Criteria of the Bidding Documents.

For the purposes of establishing Bidder's qualifications, the financial and technical capacity of any Subcontractor will not contribute to the Bidder's qualifications.

A margin of preference for certain goods manufactured domestically shall not be applied.

7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address No.1 below and upon payment of a non-refundable fee of Euro two hundred and forty (240) or its Bulgarian Lev equivalent, inclusive of VAT.

Lot 1 – Euro forty thousand (40,000) or its equivalent

Lot 2 – Euro sixteen thousand (16,000) or its equivalent
