State Fund for Guaranteeing the Stability of the State Pension System

The resources of the Fund as of 31.03.2022 total to **BGN 3 649,85 million**, of which BGN 3 649,0 million is held in an annual deposit in the Bulgarian National Bank with decision of the Managing board of the Fund.

In accordance with the provisions of paragraph 4 of article 1 and paragraph 3 of article 11 of the State Fund for Guaranteeing the Stability of the State Pension System Act in relation to paragraph 12 of article 129 of the Social Security Code in March 2022 the amount of **BGN 4.56 million** was transferred to the Fund's account.
