## SUPPLEMENTARY INFORMATION TO NEGOTIATING POSITION UNDER CHAPTER 10 "TAXATION"

(CONF-BG 22/01)

Bulgaria wishes to refer to its Negotiating Position on Chapter "TAXATION" (CONF-BG 22/01).

Bulgaria would like to confirm that it accepts the new acquis between 1 January 2002 and 30 June 2002 on Chapter "TAXATION" and will implement it as of the date of accession.

Bulgaria would like to note that in the process of negotiations a 3-year transitional period after the date of accession was granted to Bulgaria in order to reach the minimum excise duty rates under art. 2 of Council Directive 92/79/EEC, amended by Council Directive 2002/10/EC.

Bulgaria notes the Decisions, listed in the Addendum, concerning separate Member States and takes these into consideration without objection.

Bulgaria has examined the proposals for directives and decisions, the last ones concerning the Community programme to improve the operation of taxation systems in the internal market (Fiscalis 2007 programme) and the computerizing the movement and surveillance of excisable products. Bulgaria is going to present its position on these, when they become part of the legislation in force.
