SUPPLEMENTARY INFORMATION TO NEGOTIATING POSITION

ON CHAPTER 21 "REGIONAL POLICY AND COORDINATION OF STRUCTURAL INSTRUMENTS"

(CONF-BG 56/01)

Bulgaria wishes to refer to its Negotiating Position on Chapter 21 "Regional policy and coordination of structural instruments" (CONF-BG 56/01).

Bulgaria notes without objections the new *acquis* between 1 January and 30 June 2002 under Chapter 21 "Regional policy and coordination of structural instruments", as referred to in the addendum to the present Supplementary Information.

According to the legal nature of the acquis, consisting of individual Commission Decisions with regard to regions in the Member States, these acts do not require transposition into the Bulgarian national legislation.

While taking this into consideration, Bulgaria has examined with due attention the abovementioned acquis in preparing itself for participation in the EU Regional Policy.
